





Dear Friends,

2021 was a year to remember. Despite the challenges, we saw and seized opportunities to Dream Bigger in all our programs. The Alliance became a partially remote organization with most of our staff living in San Diego, California while others worked from Colorado, Idaho, New Hampshire, New Jersey, North Carolina, Pennsylvania, South Carolina, Texas, Virginia, Utah, and Washington. In 2021, we gave up our leased space in downtown San Diego to purchase a retreat center in Allenspark, Colorado with dreams to build a national training center in Estes Park, Colorado in the future. With our focus on wellness, we couldn't think of a better way to achieve our goal of becoming a hope-centered organization than to start gathering our staff, directors, front-line professionals, first responders, and survivors at a place that naturally promotes health, healing and hope.

We saw the Family Justice Center movement continue to move and dreams continue to get bigger with the grand opening of 10 new Centers even during the pandemic. They join approximately 150 centers in 44 States and 25 countries including 51 affiliated Centers who have committed to our standards for evidence-based practice. We had the honor to share the Family Justice Center Impact Report with 150 directors and leaders in Nashville, Tennessee for the Leadership Summit where we toured the largest Family Justice Center in world. We continued to be inspired and honored to work with our National and local VOICES members as they share their vision for the future and continue to be our compass.

In the face of rising domestic violence homicides, suicides, officers killed in the line of duty by domestic violence stranglers, and racial injustice, our allied Family Justice Centers and Camp HOPE America programs continued to serve hundreds of tens of thousands of adult and child survivors of domestic and sexual violence and child abuse. Camp HOPE America is now expanding to 25 states.

Our Training Institute on Strangulation Prevention continued developing new resources, advocating for new laws, building a growing presence on social media and training over 35,000 professionals annually (virtually and in-person) on how to prevent homicides by improving their response to strangulation assaults. We also saw an impact in our efforts to bring attention to unsolved cold cases through our Justice Legal Network as two homicide cases were reopened and are now under further investigation.

We encourage you to review this annual report to read about our work in Substance Use, Poly-Victimization, the science of hope, and our new Hope Tech Suite. We owe our success to YOU -- our funders, donors, sponsors, clients, volunteers and survivors. We are extremely grateful to our staff and board for their support, friendship and hard work. The best is yet to come, and the future has never been brighter. Please wear sunglasses!






**ART HEALS** is a pilot project in San Diego with the goal of increasing and maintaining high hope, while improving interpersonal communication among families. Initially implemented in partnership with Crisis House in San Diego, the desire is to eventually reach families served by Camp Hope America and Family Justice Center affiliates.



**ALLIANCE FOR HOPE INTERNATIONAL** is one of the leading systems and social change organizations in the country focused on creating innovative, collaborative, trauma-informed, hope-centered approaches to meeting the needs of survivors of domestic violence and sexual assault and their children.



**THE FAMILY JUSTICE CENTER FRAMEWORK IMPACT REPORT** was produced to highlight outcome and process studies, facts, and quotes from survivors and elected officials.



**RACIAL TRAUMA ADVISORY GROUP** established under the Alliance's Family Justice Center **POLYVICTIMIZATION INITIATIVE**, conducted a series of five focus groups and, based on focus group feedback, revised the Polyvictimization Assessment Tool used to tailor services for survivors and better provide long-term holistic services for survivors who have experience multiple forms of violence in their lives to assess for racial trauma.

The **BEST PRACTICES REPORT CARD** was produced in collaboration with Ret. Assistant District Attorney of Riverside, Jerry Fineman to measure a community's response to handling non-fatal strangulation assaults.

**BEST PRACTICES REPORT CARD** *Back to school time... because lives depend on what you know!*

We like to believe our domestic violence response is the best of the best. Maybe it is. Maybe it could be better. Take a moment to reflect on ways to improve your response. Here is a list of some of the best practices in place in various parts of the country (there are more than 10, but we picked these).

- 1 Do your dispatchers receive ongoing specialized training in handling domestic violence/strangulation cases?  YES  NO/UNSURE
- 2 Are all your sworn law enforcement personnel training on investigating strangulation cases and does their training include a duty to warn victims about the potential dangers of strangulation? You can answer yes if all your cases are handled by a DV Response Team that uses a duty to warn.  YES  NO/UNSURE
- 3 Are your paramedics specially trained in responding to strangulation cases?  YES  NO/UNSURE
- 4 Are all your assigned prosecutors trained on investigating and prosecuting strangulation cases?  YES  NO/UNSURE



With the help of **NOVIR**, a renowned COVID Diagnostics company, and hundreds of donors we **RAISED \$30,000** to help send **1,200 PARTICIPANTS** to camp safely (nationwide, we had only four known positive cases and no outbreaks at camp).

Made possible by Verizon, **THE HOPE COACH OF THE YEAR AWARD** was created to recognize young mentors in the Camp HOPE America program, and provide a grant for their local program. Hope Coaches are trained to understand the Science of Hope, and have a life-coaching approach.

Also introduced in 2021, **THE CAMPER OF THE YEAR AWARD** acknowledges a camper who exemplified hope while at camp. The National Football League Players Association is celebrating the camper by covering their camp fees for the upcoming summer.


